

TERMS AND CONDITIONS FOR SUBMITTING PROPOSALS

BY THEATRE GROUPS OR INDIVIDUALS NOT RESIDING IN CYPRUS

FOR THE 2015 INTERNATIONAL FESTIVAL OF ANCIENT GREEK DRAMA

The Cyprus Centre of the International Theatre Institute, the Ministry of Education and Culture, Cultural Services and the Cyprus Tourism Organization announce the *2015 International Festival of Ancient Greek Drama*, which will be held during the whole month of July 2015 in Cyprus.

The International Festival of Ancient Greek Drama has been established as an outstanding institution, which is characterized by its international identity. The selected performances are presented in open-air amphitheatres, such as the Paphos Ancient Odeon, the Curium Ancient Theatre and the Makarios III Amphitheatre in Nicosia.

The proposed performances must be based on the original text of the tragedians and comedians of antiquity.

Interested theatre groups and individuals should consider the following:

A. Quality of the proposals:

- 1. The proposals to be submitted should clearly state the artistic part of the performance, additionally to cast and credits.
- 2. The proposal should include the producer's profile (theatre group or individual), the theatre group's or individual's profile, the translator, the director, the cast and credits of the performance and the proposed dates which the theatre group can travel to Cyprus, in case the Selection Committee chooses the performance. The proposal is valid only if a CD/DVD/USB of the performance is sent to the Cyprus Centre of the I.T.I.
- 3. The proposals shall be reviewed/evaluated by the Selection Committee consisted of three members representing the Cyprus Centre of the I.T.I., three members representing the Cultural Services of the Ministry of Education and Culture and one member representing the Cyprus Tourism Organization. The Selection Committee should choose the performances which are participating in the Festival.

B. Procedural:

- 1. The selected theatre groups or individuals shall sign a contract with the Cyprus Centre of the I.T.I.
- 2. If a proposal is submitted by a mediator, an official letter from the theatre group or individual should accompany the application, stating that the theatre group or individual authorize the mediator to submit on their behalf.

- 3. Tickets are issued on the behalf of the Cyprus Centre of the I.T.I. The right of admission is reserved by the Cyprus Centre of the I.T.I.
- 4. A proposal will be considered valid only if it is submitted within the required deadline and all related material (artistic and technical) are included in the application.
- 5. All proposals from theatre groups or individuals expressing interest in participating in the 2015 International Festival of Ancient Greek Drama should be submitted using the form available at www.greekdramafest.com
- 6. The deadline for submitting the interest to participate is 9 January 2015. If a proposal is mailed, the official post office stamp will be applied. Envelopes containing the proposals should be titled "2015 International Festival of Ancient Greek Drama" and should be sent to:

- 7. The envelope should include: the form (the interested theatre groups or individuals should fill, stamp and sign the form), the theatre group's or individual CV, the director's and main cast member's profiles, the cast and credits, a CD/DVD/USB with high resolution publicity photographs of the performance, a Screener CD/DVD/USB of the performance and the technical requirements. All audiovisual material should be released of any copyrights and will be used for publicity reasons of the Festival.
- 8. When a performance is selected, the theatre group or individual is responsible for and must submit evidence proving that the rights as regards the artistic credits, creators, translation and music that will be part of the performance are secured. These must be submitted prior to the presentation of the performance, otherwise the selection shall be considered void.
- 9. If the proposal of the theatre group or individual is modified <u>less than three months before its presentation at the Festival</u>, the proposal will not be valid. In such an event, the Organizers reserve the right to review or even cancel the participation.
- 10. The Cyprus Centre of I.T.I. will provide the necessary audiovisual support for the materialization of the Festival according to the needs of each performance. If a performance is selected, the selected theatre group or individual will submit a complete and final list of the technical requirements, as well as the text of the performance in electronic format.
- 11. The Cyprus Centre of the I.T.I. will cover accommodation (in twin rooms), 3 daily meals, transportation to and from Cyprus and transportation to and from venues.
- 12. Submission of a proposal is equal to acceptance of ALL terms and conditions of the Organizers.
